- Learned Advocate for the Petitioner Company states that pursuant to the 3. order dated 1st March, 2017 passed in the Company Scheme Application No. 187 of 2017 annexed as Exhibit "L" to the Petition, the meetings of the equity shareholders and unsecured creditors of the Petitioner Company were convened on Tuesday, the 8th day of May, 2017 at 10:00 a.m. and 10:45 a.m. respectively at #402, Suyog Fusion, Dhole Patil Road, Sangamwadi, Pune 411001, for the purpose of considering, and if thought fit, approving, the Scheme of Arrangement between Tata Chemicals Limited and the Petitioner Company and their respective shareholders and creditors.
