


**ORDER**

Petitioner is present. Respondent Company is represented by its authorised signatory Shri CS Venugopala Rao Chitoori. R2 Company's is represented by its authorised signatory Shri R Kiran Gupta. GPA of R4, R5 and R6 who is Shri R Kiran Gupta is present. GPA of R7 Shri CS Venugopala Rao Chitoori is also present in person. Compromise memo along with terms of compromise is filed on behalf of both the sides, signed by the parties. The terms were explained to the Petitioner who is present in person, who is represented by Counsel and he is also present.
