## **ORDER**

- 1. The present Company Application bearing CA No.207 of 2017 in CP No.55/2008 is filed by BEML Ltd under Rules 11 & 32 of NCLT Rules, 2016, by interalia seeking to direct investigating officers to complete investigation officers to complete the investigation and to submit a report in a time bound manner etc.
- 2. The case was initially instituted in the then Company Law Board and its stands transferred to this Bench, on its constitution. Accordingly, the case stands posted to various dates viz: 01.09.2017, 08.09.2017, 08.11.2017, 15.11.2017 &30.11.2017 for hearing. During the course of hearing of main case, the petitioner has filed said CA No. 185 of 17.
- 3. Heard Mr S.Sriranga the learned counsel for the Applicant/Petitioner and Mr.Inti Venkateswarlu, learned counsel for the Respondent No.2.
- 4. Mr.Sriranga the learned counsel for the applicant submit that the then Company Law Board, disposed of both CP No. 55 of 2008 and CP No. 02 of 2009 vide common order 01.06.2012 by interalia directing the Central Government to appoint an Inspector to investigate the affairs of BEML Midwest Limited and the conduct of BEML and Midwest group and its nominee directors in the affairs of M/s BEML Midwest Ltd, within six months from the date of receipt of a copy of this order and to take action on receipt of investigation report.



5. Aggrieved by the said common order dated 01.06.2012, the applicant /petitioner herein has filed a Company Appeal bearing CA No.7 and 12 of 2013 before the Hon'ble High Court of Judicature at Hyderabad. And the Hon'ble High Court, also vide its Order dated 19.08.2013 disposed off the same by set aside the said common order dated 01.06.2012 and remanded the matter to Company Law Board (CLB), Chennai for fresh adjudication and also directed the CLB to proceed with the enquiry and decide the issues in accordance with law on merits also taking into consideration the result of investigation and pass appropriate orders.



- In pursuant to the Common Order dated 01.06.2012 of the Hon'ble Company Law Board, Chennai and the Judgment of Hon'ble High Court of Hyderabad dated 19.08.2013, the Regional Director, Ministry Corporate Affairs, South Eastern Region, at Hyderabad, vide its letter F.No. JDI Insp/RD(SER/Sec-235/2014/8572 dated 13.01.2014 intimated to the parties that Shashi Raj Dara, Deputy Registrar of Companies, AP and Dola Raghunath Assistant Director O/o RD(SER) Hyderabad have been appointed as Inspectors by the Central Government for purpose of investigation in question with direction to complete their investigation and submit their report.
- 7. The learned counsel now submit that they are not aware as to what happened to the said enquiry and could not argue the matter and they are suffering a lot by virtue of non-completion of investigation. All the records are with the Department for

investigation. Hence, the present application has been filed with relief as mentioned supra.

8. After perusing the records of Tribunal, there is no report available and no developments with regard to said investigation filed in the Tribunal. Therefore, in order to decide the matter, which is pending since 2008, we want to know the fate of said enquiry, in order to decide the case without further delay.

Post the case for final on 14.12.2017 immediately below admission.
