ORDER 11-09-2017

This application under 241,242,243, 244 and 210 of the Companies Act, 2013 is filed by Shanta Prasad Chakraborty & others against M/s. Madarkhat Tea Co. Pvt. Ltd. & Ors. seeking relief/s as specified in the petition.

2. On receipt of the application, the Registry has scrutinized the same and noticed some defects therein. - i. Kindly provide the breakup of the fees paid under the above provisions.
- ii. Under section 244(1) (a), it is provided that the entitled class of shareholders can file the company petition subject to the condition that the applicant or applicants have paid all calls and other sums due on his or their shares. You are requested to verify the same by means of a separate declaration from the petitioners.
- iii. Please note that at the signature page of the petition, the place and date of signature is not filled up. You are kindly requested to fill the same.

- iv. It appears that the petition is a joint petition. In the event that it is a joint petition, consent in writing from the other petitioners authorizing the petitioner number 1 to file the petition needs to be filed along with the main documents (Please check section 244, clause of Companies Act, 2013 and rule 81 (2) of NCLT Rules, 2016).
- v. Service affidavit certifying that a copy of the petition has been served on all the respondents required.
- vi. Three sets of authenticated copies of the petition has to be filed as per rule 24 of NCLT Rules, 2016. Please ensure that all the three copies of the petition filed with the Bench are authenticated copies.
