ORDER

1. Petition admitted.

- 2. Petition fixed for hearing and final disposal on 21st February, 2018.
- 3. Learned Counsel for the Petitioner Company states that in pursuance of the directions contained in its Order dated 4th September, 2017, passed by the National Law Company Tribunal, Mumbai Bench ('Tribunal') in Company Scheme Application No. 44 of 2017, the meeting of Equity Shareholders was held on Wednesday, 25th October, 2017, at 11.30 a.m., and the requisite quorum was present and the Scheme was approved without modifications by the Equity Shareholders. The Chairman appointed for the meeting has submitted his report to the Tribunal on 30th October, 2017, which is annexed as Exhibit "Q" to the Company Scheme Petition. The notice of the meeting of the Equity Shareholders was also served upon the unsecured creditors of the Petitioner Company.

- The Learned Counsel for the Petitioner Company further submits that the Company Scheme Petition is filed in consonance with section 230 to 232 and other applicable provisions of the Companies Act, 2013.
- 6. At least ten (10) days before the date fixed for hearing, the Petitioner Company to publish the notice of hearing of Petition in two local newspaper viz. "Free Press Journal", in English language and translation thereof in "Navshakti", in Marathi language, both having circulation in Mumbai as per Rule 16 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016.
- 7. The Petitioner Company to file an affidavit of service regarding the directions given by the Tribunal and do report to this Tribunal that the

direction regarding the issue of advertisement of the notice has been duly complied with.
