- 1. Petition admitted
- Petition fixed for hearing on 21st December, 2017.
- 3. Learned Advocate for the Petitioner Company submits that in pursuance of Order dated14th September, 2017 passed by this Tribunal in Company Scheme Application No 865of 2017, meeting of the Equity Shareholders of the Petitioner Company was convened and held at GW-8101, G Tower, Bharat Diamond Bourse, Bandra Kurla Complex, Bandra (East), Mumbai 400 051 on Wednesday, 18th October, 2017, at

10.00 a.m.and the requisite quorum was present and the Scheme was approved with the requisite majority by the Equity Shareholders with modifications. The Chairperson appointed for the meeting has filed his affidavit verifying his report dated 18thOctober, 2017 which is annexed as 'Annexure – G' to the petition.
