Perused the records of the case which reflect that there were three CAs, namely, CA No. 342/2011, CA No. 64/2012 and CA No. 586/2013 and all the three CAs. have now become infructuous in view of the Order dated 27th March, 2014 of the Hon'ble High Court, Calcutta and thereafter, application for amendment of the main CP has also been filed by the petitioner which is also allowed vide CA No. 802/2014. Hence the aforesaid CAs. stand disposed of.

Further, on allowing of CA No. 802/2014 vide order dated 03-07-2015 of the then CLB to amend the main CP 450/2011 by addition of two paragraphs viz. paragraph (mm) 1 and paragraph (mm) 2, the CA No. 802/2014 also gets disposed of.
