**ORDER**

Mr. Krishnendu Datta, Learned Counsel for the petitioner has referred to Section 9 (3) (c) of the IBC and has raised the objection that a copy of the certificate from the Financial Institution in respect of the operational creditors confirming that there was no payment of unpaid debt by the Corporate debtor should have been attached with the application. Since the aforesaid certificate has not been filed, learned Counsel has argued that the application is liable to be dismissed in pursuance of Section 9(5) (ii).



However, we find that in accordance with the provisions of Section 9(5) proviso, the Adjudicating Authority is obliged to give notice to the applicant to rectify the defects in the application within 7 days of the receipt of notice from the Adjudicating Authority pertaining to such defects.

Accordingly, we grant time to the applicant to rectify the defects and file the aforesaid certificate in terms of Section 9 (3) (c) of the Code.

The needful shall be done on or before 01.5.2017.
