

1. The Learned Representatives of both the sides are present.
2. The Petitioner has filed a Rejoinder and the copy has been handed over to the Respondents. However, respondents are seeking time to file Sur-rejoinder which can be filed on or before 8th February, 2017.

3. A discussion was made in the Court pertaining to the possibility of amicable settlement for a 'buy or sale' offer of the property, which can be made by either side.
4. For this purpose Valuation is required. The Respondent has taken the responsibility to value the assets of the Respondent No.1 Company.
