MINUTES OF ORDER

1. Heard learned Counsel for parties. No objector has come before this Tribunal to oppose the Scheme and nor has any party controverted any averments made in the Petitions.
2. The sanction of this Tribunal is sought under Sections 230 to 232 of the Companies Act, 2013, to a Scheme of Amalgamation of M/s. Achala Electricals Private Limited, the First Transferor Company and M/s. Manasvi Consultancy Private Limited, the Second Transferor Company and M/s. Darshanik Valueserve Private Limited, the Third Transferor Company M/s. Accelerate Tradestar Private Limited, the Fourth Transferor Company with M/s. Azura Projects Private Limited, Transferee Company.
3. The Petitioner Company and the Transferee Company have approved the said Scheme of Amalgamation by passing the Board Resolutions which are annexed to the respective Company Scheme Petitions.
4. The learned Advocate for the Petitioner Companies further states that the Scheme of Amalgamation will have the benefit That the merger will make available assets, financial, managerial and technical resources, personnel, capabilities, skills, and expertise of both the Transferor Companies and the Transferee Company leading to enhancement of future business potential, increased competitiveness, cost reduction and better efficiencies, productivity gains and logistical advantages, thereby contributing to significant

future growth and enhancement of shareholder value. Consolidation of the business operations of the Transferor Companies and the Transferee Company for optimizing the control over the operations more efficiently, conveniently, economically and advantageously under single management and Greater efficiency in cash management of the combined entity, unfettered access to cash flow generated by the combined business which can be deployed more efficiently to fund organic and inorganic growth opportunities.

5. The Learned Advocate appearing on behalf of the Petitioner has stated that the Petitioner Company has complied with all requirements as per directions of the Hon'ble Bombay High Court and this Tribunal and they have filed necessary Affidavits of compliance in this Tribunal. Moreover, the Petitioner Company undertakes to comply with all statutory requirements, if any, as required under the Companies Act, 2013 and the Rules made there under whichever is applicable. The said undertaking is accepted.
6. The Regional Director has filed his Report on 12th April 2017, inter alia, stating therein that save and except as stated in paragraphs IV (1) to (4) of the said Report, it appears that the Scheme is not prejudicial to the interest of the shareholders and public. In paragraph IV of the said Affidavit, the Regional Director has stated that:

“IV. The observations of the Regional directors on the proposed Scheme to be considered by the Hon'ble NCLT are as under:-

- a) *In addition to compliance of AS-14 (IND AS – 103) the Transferee Company shall pass such accounting entries which are necessary in connection with the scheme to comply with other applicable Accounting Standards such as AS – 5 (IND AS – 8) etc;*

- b) *As per clause 1.2 of the scheme " The Appointed Date" Means opening business hours of 1st April, 2016 or such other date as may be fixed or approved by the High Court of Judicature at Bombay. In this regard, it is submitted in terms of provisions of section 232 (6) of the Companies Act, 2013 it should be 1st April, 2016;*
- c) *As per existing practice, the petitioner Companies are required to serve Notice for Scheme of Arrangements to the Income Tax Department for their comments. It appears that the company vide letter dated 27th January 2017 has served a copy company scheme petition No. 42 to 45 / 2017 along with relevant orders etc, further the Regional Director has also issued a reminder 30th March 2017, to IT Department.*
- d) *The tax implication if any arising out of the scheme is subject to final decision of Income Tax Authorities. The approval of the scheme by this Hon'ble Court may not deter the Income Tax Authority to scrutinize the tax return filed by the transferee Company after giving effect to the scheme. The decision of the income Tax Authority is binding on the petition Company."*
7. The Regional Director in his report stated in paragraphs III(12) that the Registrar of Companies in his report at Point 29 mentioned that the Company to submit a certificate by its Auditor to the Tribunal in terms of proviso to section 232(3) of the Companies Act,2013.
8. In response to the above observations the Petitioner Company filed its affidavit in reply dated 12th April, 2017 to the report of Regional Director.
9. As far as the observation of the Regional Director stated in paragraph IV (a) of his report is concerned, the Petitioners are undertakes that in addition to compliance of AS-14 (IND AS – 103) the Transferee Company shall pass such accounting entries which are necessary in connection with the scheme to comply with other applicable Accounting Standards such as AS – 5 (IND AS – 8) etc.
10. As far as the observation of the Regional Director stated in paragraph IV (b) of his report is concerned, the Petitioners are

undertakes that the Appointed Date for the Scheme shall be 1st April, 2016.

11. As far as the observation of the Regional Director stated in paragraph IV (c) and (d) of his report is concerned, the Petitioners are undertakes to comply with all applicable provisions of the Income Tax Act and all tax issues arising out of the Scheme will be met and answered in accordance with law.
12. In respect of the observation made in paragraph III (12) of the Report of Regional Director is Concerned the Petitioner Company submits that the Petitioner Company has obtained necessary certificate from the Chartered Accountant as per the provision of Section 232(3) of the Companies Act, 2013 and filed the same with this Tribunal.
13. The Official Liquidator has filed his report in the Company Scheme Petition Nos. 42 of 2017 and 45 of 2017 and official Liquidator states that they have no objection to the Present Scheme.
14. From the material on record, the Scheme of Amalgamation appears to be fair and reasonable and is not violative of any provisions of law and is not contrary to public policy.
15. Since all the requisite statutory compliances have been fulfilled, Transferred Company Scheme Petition Nos.42 of 2017 to 45 of 2017 are made absolute in terms of prayer clauses (a) to (d) of the respective Petitions.
16. Petitioner Company is directed to file a copy of this Order along with a copy of the Scheme of Amalgamation with the concerned Registrar of Companies, electronically, along with E-Form INC-28,

in addition to the physical copy within 30 days from the date of issuance of the Order by the Registry.

17. The Petitioner Company to lodge a copy of this Order and the Scheme duly authenticated by the Deputy Director, National Company Law Tribunal, Mumbai Bench, with the concerned Superintendent of Stamps for the purpose of adjudication of stamp duty payable, if any, on the same within 60 days from the date of receipt of the Order.
18. The Petitioner Companies to pay costs of Rs.25,000/- each to the Regional Director, Western Region, Mumbai and to the Official Liquidator, High Court, Bombay to be paid within four weeks from the date of Order.
19. Costs to be paid within four weeks from today.
20. All authorities concerned to act on a copy of this Order along with Scheme duly authenticated by the Deputy Director, National Company Law Tribunal, Mumbai Bench.
21. Any person interested shall be at liberty to apply to the Tribunal in the above matter for any direction that may be necessary.
