Therefore, there is necessity for extension of period to complete corporate insolvency process. Considering the above stated reason shown in his application, which appears

to be reasonable and convincing. Hence, his request is exceeded to the petition is allowed in terms of its prayer clause by extending further period of 90 days after completion of initial 180 days (w.e.f 17.09.2017). A copy of this order be communicated to the RP.
