The present application is field before this Tribunal seeking a direction from us to be issued to the IRP to differ its further cause of action till Hon'ble NCLAT, hears the matter on stay application filed by Corporate Debtor Company in pending appeals, which are now subjudice because the Hon'ble NCLAT has fixed the next date of hearing in the pending is fixed on 14th July, 2017.

However, it is also stated that meanwhile, the learned IRP has proposed his plan to make visit of the Corporate Debtor company for taking further course of action, as per the I & B Code.

Contrary to this the learned counsel for operational counsel contended that this Courts has now become functus officio as the appeal and subject matter is now seized of by the Hon'ble NCLAT.

Hence, this court cannot be expected to issue further direction/

or to grant such relief in favour of the applicants.

Having heard the rival submissions made by the of counsel of both the parties. We are of the view, that since, there is no express stay from the Hon'ble NCLAT against proposed action of the IR.P being taken under the provision of I &B Code. It would not be proper for this Forum to issue further direction to him. As the matter is now seized of by the Higher Appellate Forum.

Notwithstanding the above, keeping in mind the Principle of judicial discipline & propriety as well as principle of the Rule of Law. The IR.P is expected to consider such circumstances as being a prudent person and can await for the order/ interim direction, that may be passed by the Hon'ble NCLAT in the pending appeals, on such stay application. Which are proposed to be heard on 14th July, 2017. He may consider to reschedule his proposed visit after 14th July, 2017 and thereafter to act as per order/ direction of the Hon'ble Appellate Forum.

With such observation the CA No. 108/2017 is disposed of. No order as to cost.
