Sh. Ashish Kumar Srivastava, Advocate for the petitioner company. Dr. Jaiswal, PCMA representative for the respondents. Learned counsel/representative of both the parties have brought to our notice about the latest order passed by the Hon'ble Supreme Court on 21st July, 2017, in respect of the present matter, extending the time for making inspection by another four weeks from date 21.07.2017. Ashok Kumar Aggarwal should inform in writing to this Tribunal in express term about his willingness to continue to complete the task as directed by the Company Law Board and further affirmed by the Hon'ble Supreme Court within stipulated period. In case, he is not inclined to complete this task due to his personal reason, he shall inform in writing to this Tribunal within three days from the date of receipt of this order, failing which this Tribunal may presume that he is not interested in to continue with the inspection work/task and alternative arrangement to be made. In view of this, the petitioner counsel is instructed to

communicate/send a copy of this order to the Chartered Accountant Sh. Ashok Kumar Aggarwal as well as to the Regional Director (NR). The petitioner counsel is also granted liberty to suggest alternative names (minimum two names) of the proposed Chartered Accountants.
