

Order

Since the Counsel appearing on behalf of R7 & 8 has sought time to filling reply, the Petitioner Counsel has raised an objection stating that these Respondents have not filed reply for more than 1½ years, hence sought for waiving right of filing reply.

However, this bench peremptorily directed R7&8 to file reply in 15 days' time with costs of ₹5000 payable at NCLT, Mumbai within one week hereafter.

The Rejoinder filed by the Petitioner to the reply filed by R1-3,6 & 9 is taken on record.

The Petitioner is at liberty to file rejoinder to the reply of R7&8 within one week thereafter.
