respondents. Registry to do the needful. In case any claim has been

made by the Allahabad Bank as financial creditor it is for the Resolution

Professional-applicant to dispose of.

It is further directed that applicant shall supply copy of the

application alongwith its annexures to the counsel for the respondents

on proper receipt, during course of the day or send the same at their

e-mail addresses. Learned counsel for the respondents shall supply their

e-mail addresses to the applicant.

Service of respondent No.3 is still to be effected. The

applicant shall collect notice from the Registry and send the same

alongwith copy of the application and the entire Paper Book to

respondent No.3 by Speed Post as well as on the e-mail address

available with the Resolution Professional for 31.01.2018.

The reply by other set of respondents be filed at least two

days before the date fixed. Learned counsel for the Punjab & Sind Bank

submits that possession was taken over by the bank as mentioned in the

reply but it was forcibly taken back by the corporate debtor for which

complaint was also lodged with the police. Before passing of any order

on this controversy, response from respondent No.2 is required.

Learned counsel for respondents has stated that there would

be no obstruction by the respondents on taking into possession on the

immoveable assets of the corporate debtor by the Resolution Process.

The Resolution Professional to proceed further in the matter and file his

report. The Bank officials may also accompany the applicant. If need

be, the applicant can seek police assistance while taking possession of immoveable assets of the corporate debtor.
