1. This Order is with regard to the Petition No. CP/477 (IB)/CB/2017, wherein on 31.05.2017, an Order came to be passed by this Bench admitting the Application and declaring the moratorium. - 3. The Operational Creditor and Registry are directed to inform the IRP to make public announcement within three days from the date the copy of the Order is received and

take over the charge of the management/asset of the Corporate Debtor. This shall form part of the order dated 31.05.2017. A copy of this Order shall immediately be sent to Operational Creditor and Corporate Debtor.
