The petitioner is asked to make necessary amendment in the Title page of CP No. 05/2016 with a copy to the respondent Nos. 1 to 4 as well as to the newly added respondent, namely, Ms. Reshmi Bubna.

The respondent Nos. 1 to 4 as well as the newly impleaded respondent have the liberty to file their written objection, if any.

The Ld. Lawyer on behalf of the petitioner is directed to serve a copy of the amended petition to the respondents within a period of one week from the date of receipt of certified copy of this order and further two weeks' time is allowed to the respondents to file their objection, if any and one week's time is allowed to the petitioners to file their rejoinder, if any.
