MINUTES OF THE ORDER

1. Petition Admitted.

2. Petition fixed for hearing and final disposal on 20th July, 2017.
3. Learned Advocate for the Petitioner states that in pursuance of the directions contained in Order dated 29th March, 2017 passed by the National Company Law Tribunal, Mumbai Bench ('Tribunal') in the Company Scheme Application No. 286 of 2017, the meeting of Equity Shareholders was held on Monday, 15th May, 2017 and the requisite quorum was present and the Scheme was approved unanimously by the Equity Shareholders without modifications. The Chairman appointed for the meeting of the equity shareholders has filed his affidavit verifying his report dated 15th May, 2017 which is annexed as Exhibit 'G' to the petition. As per the directions of the Hon'ble Tribunal vide Order dated 29th March, 2017, notice to its Secured Creditors and Unsecured Creditors were given on 11th April, 2017.
4. The Learned Advocate for the Petitioner Company further submits that the Company Petition is filed in consonance with sections 230 to 232 along with the Order passed in Company Scheme Application No. 286 of 2017 by the Tribunal.
5. At least 10 days before the date fixed for hearing, Petitioner to publish the notice of hearing of Petition in two local newspapers viz. "Free Press Journal", in English language and translation thereof in "Navashakti", in Marathi language, both having circulation in Mumbai as per Rule 16 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016.
6. The Petitioner Company to file an affidavit of service regarding the directions given by the Tribunal three days before the date fixed for final hearing and do report to this Tribunal that the direction regarding the issue of advertisement of the notice has been duly complied with.
