1. Petition Admitted.
2. Petition fixed for hearing and final disposal on 26 July, 2017.
3. Learned Counsel for the Petitioner Company submits that in pursuance of Order dated 20th April, 2017 passed by the National Company Law Tribunal, Mumbai Bench in Company Scheme Application No. 389 of 2017, the meeting of the Equity Shareholders of the Petitioner Company was convened and held on Monday, 5th June, 2017 at 11:00 A.M. and the requisite quorum was present and the said Scheme was approved by requisite majority without any modifications. The Chairman appointed for the said meeting has filed his affidavit verifying his report dated June 6th, 2017, which is annexed as Exhibit _ to the Petition.
4. Learned Counsel for the Petitioner Company further submits that the Company Petition is filed in consonance with section 230 to 232 of the Companies Act, 2013 along with the Order passed in Company Application No. 380 of 2017 by the National Company Law Tribunal, Mumbai Bench.
