1. Petition Admitted.
2. Petition fixed for hearing and final disposal on 29th June, 2017.
3. Learned Counsel for the Petitioner states that in pursuance of the directions contained in Order dated 15th February, 2017 passed by the National Company Law Tribunal, Mumbai Bench in the Company Application No. 78 of 2017, the meeting of Equity Shareholders was held on Tuesday, 18th April, 2017 and the requisite quorum was present and the Scheme was approved unanimously by the Equity Shareholders without modifications. The Chairman appointed for the meeting has filed his affidavit verifying his report dated 21st April, 2017 which is annexed as Exhibit 'I' to the petition.
4. The Learned Counsel for the Petitioner Company further submits that the Company Petition is filed in consonance with section 230 to 232 of the Companies Act, 2013 along with the Order passed in Company Application No. 78 of 2017 by the National Company Law Tribunal, Mumbai Bench.
