- 1. Petition admitted.
- 2. Petition fixed for hearing on 6th September 2017.
- 3. Learned counsel for the Petitioner Company submits that in pursuance of Order dated 3rd May 2017 passed by the Tribunal in Company Scheme Application No.538 of 2017, the meeting of the Equity Shareholders of the Petitioner Company was convened and held at Gate No. 154/1 Mahalunge Village, Post Chakan, Pune, Maharashtra 410501 on 12th June, 2017 at 10.30 AM respectively for the purposes of considering and if thought fit, approving with or without modification the proposed Scheme of Amalgamation Of Sigma Electric Manufacturing Corporation Pvt. Ltd. (the Transferor Company) with Sigma Electric Manufacturing

Pvt. Ltd. (the Transferee Company) and their Shareholders. In the said meeting the Scheme was approved by requisite majority representing 100% in value and in number of the equity shareholders present at the meeting. The Chairman of the meeting has submitted his report stating the outcome of the meeting alongwith Affidavit dated 4th July 2017 verifying the said Report

- 4. The Counsel for the Petitioner further submits that as directed by this Tribunal notices have been served upon all the Regulatory Authorities namely, concerned Income Tax Authorities, Central Government through the Office of the Regional Director, Western Region Mumbai, Registrar of Companies, Mumbai, The Official Liquidator, High Court Bombay and upon the unsecured creditors.
- 5. The Learned Counsel for the Petitioner Company further states that the Company Petition is filed in consonance with Sections 230 to 232 of the Companies Act, 2013 and alongwith the order passed in Company Scheme Application 538 of 2017.
- 6. Atleast 30 clear days before the date fixed for hearing, Petitioner Company to serve notice upon the Regional Director, Western Region, Ministry of Corporate Affairs, Mumbai, Maharashtra, pursuant to Section 230(5) of the Companies Act, 2013 as per Rule 8 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016. If no response is received from the Regional Director within thirty days of the date of receipt of the notice, it will be presumed that the Regional Director and/or the Central Government has no objection to the proposed Scheme as per Rule 8 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016.
- 7. Atleast 30 clear days before the date fixed for hearing, Petitioner Company to serve notice upon the concerned Registrar of Companies pursuant to Section 230(5) of the Companies Act, 2013 as per Rule 8 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016. If no response is received from the concerned Registrar of

Companies within thirty days of the date of receipt of the notice, it will be presumed that the concerned Registrar of Companies has no objection to the proposed Scheme as per Rule 8 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016.

- 8. Atleast 30 days before the date fixed for hearing, Petitioner to serve notice on the concerned Income Tax Authority within whose jurisdiction the Petitioner company's assessment are made, with a direction that the Income Tax Authority may submit their comments/views/remark on the tax aspects of the Scheme to the concerned Regional Director within 15 days from the receipt of the notice of the hearing of the Petition, in terms of General Circular No.1/2014,F.No.2/2014 dated 15th January 2014,issued by Ministry of Corporate Affairs, Government of India.
- 9. At least 10 clear days before the date fixed for hearing, Petitioner Company to publish the Notice of hearing of Petition in Pune edition of "Indian Express" in English and Pune edition of "Loksatta" in Marathi both circulated in Pune.
- 10. The Petitioner to file an affidavit regarding the directions given by the Tribunal 3 (Three) days before the date fixed for hearing and report to this Tribunal that the direction regarding the issue of advertisement of notice has been duly complied with.
