1. Petition admitted.
2. Petition fixed for hearing on 6<sup>th</sup> September 2017.
3. Learned counsel for the Petitioner Company submits that in pursuance of Order dated 3<sup>rd</sup> May 2017 passed by the Tribunal in Company Scheme Application No.538 of 2017, the meeting of the Equity Shareholders of the Petitioner Company was convened and held at Gate No. 154/1 Mahalunge Village, Post Chakan, Pune, Maharashtra - 410501 on 12th June, 2017 at 12:00 noon for the purposes of considering and if thought fit, approving with or without modification the proposed Scheme of



Amalgamation Of Sigma Electric Manufacturing Corporation Pvt. Ltd. (the Transferor Company) with Sigma Electric Manufacturing Pvt. Ltd. (the Transferee Company) and their Shareholders. In the said meeting the Scheme was approved by absolute majority representing 100% in value and in number of the equity shareholders present at the meeting. The Chairman of the meeting has submitted his report stating the outcome of the meeting along with Affidavit dated 4<sup>th</sup> July 2017 verifying the said Report

4. The Counsel for the Petitioner further submits that as directed by this Hon'ble Tribunal under the Order dated 3<sup>rd</sup> May 2017 notices of the meeting of the equity shareholders have been served upon all the Regulatory Authorities namely, the concerned Income Tax Authorities, Central Government through the Office of the Regional Director, Western Region Mumbai, Registrar of Companies, Pune, and the unsecured Creditors.
5. The Learned Counsel for the Petitioner Company further states that the Company Scheme Petition is filed in consonance with Sections 230 to 232 of the Companies Act, 2013, as well as the Order dated 3<sup>rd</sup> May 2017 passed in Company Scheme Application 538 of 2017.
6. Atleast 30 clear days before the date fixed for hearing of the Company Scheme Petition, the Petitioner Company to serve notice of hearing along with a copy of the Company Scheme Petition, upon the Regional Director, Western Region, Ministry of Corporate Affairs, Mumbai, Maharashtra.
7. Atleast 30 clear days before the date fixed for hearing of the Company Scheme Petition, the Petitioner Company to serve a notice of hearing along with a copy of the Company Scheme Petition, upon the Official Liquidator, High Court Bombay.
8. Atleast 30 clear days before the date fixed for hearing of the Company Scheme Petition, the Petitioner Company to serve notice of hearing along with a copy of the Company Scheme Petition, upon the concerned Registrar of Companies, Pune.



9. Atleast 30 days before the date fixed for hearing of the Company Scheme Petition, the Petitioner Company to serve a notice of hearing along with a copy of the Company Scheme Petition, upon the concerned Income Tax Authority within whose jurisdiction the Petitioner company's assessment is made.
10. At least 10 clear days before the date fixed for hearing, Petitioner Company to publish the Notice of hearing of Petition in Pune edition of "Indian Express" in English and Pune edition of "Loksatta" in Marathi, both circulated in Pune.
11. The Petitioner to file an affidavit regarding the directions given by the Tribunal 3 (Three) days before the date fixed for hearing and report to this Tribunal that the direction regarding the issue of advertisement of notice has been duly complied with.
