Learned Counsel for the Petitioner Companies submit that in pursuance of Order dated 5th April, 2017 passed by this Tribunal in Company Scheme Application No 263 of 2016, meeting of the Equity Shareholders of the First Petitioner Company, Second Petitioner Company, Third Petitioner Company, Fourth Petitioner Company and Fifth Petitioner Company was convened and held at 15th Floor Urmi Estate, Tower A, 95, Ganpatrao Kadam Marg, Lower Parel West, Mumbai 400013 on Tuesday, 23rd May, 2017 at 10:00 A.M., 11:00 A.M., 12:00 P.M., 2:00 P.M and 3:00
