- 3. Advance notice of the application was served and on behalf of R4A to R4F learned counsel has put in appearance. Learned counsel for R4A to R4F has not raised any objection for condoning the shortfall of 05 days in issuance of notice.
- 4. Having heard the learned counsel for the parties, we are of the view that in order to adhere to the statutory compliances for the affairs of the company, the shortfall in serving the notice for convening of the AGM which is less than 21 days, deserves to be condoned in the interest of justice and to sub serve the interest of the company. R1 company has not been holding AGM for the last three years which may result in disastrous situation and prove damaging for the company.
- 5. Accordingly, the shortfall in issuance of notice is condoned and the meeting be held as scheduled.

The application stands disposed of.
